## GRANT OF “LEVER-RULE” PROTECTION

**AGENCY:** Customs and Border Protection (CBP), Department of Homeland Security.

**ACTION:** Notice of grant of “Lever-Rule” protection.

**SUMMARY:** Pursuant to 19 CFR 133.2(f), this notice advises interested parties that CBP has granted “Lever-Rule” protection to BIC Corporation. Notice of the receipt of an application for “Lever-Rule” protection was published in the December 4, 2019, issue of the Customs Bulletin.

#### BACKGROUND

Pursuant to 19 CFR 133.2(f), this notice advises interested parties that CBP has granted “Lever-Rule” protection for pocket lighters intended for sale in countries outside the United States, bearing the “BIC” mark, U.S. Trademark Registration No. 2,324,480/CBP Recordation No. TMK 18-00388; the “BIC & DESIGN” mark, U.S. Trademark Registration No. 951,661/CBP Recordation No. TMK 03-00707; the “LIGHTER CONFIGURATION DESIGN” mark, U.S. Trademark Registration No. 2,324,480/CBP Recordation No. TMK 18-00388; and the “DESIGN ONLY (CHILD RESISTANT LIGHTER CONFIGURATION)” mark, U.S. Trademark Registration No. 2,278,917/CBP Recordation No. TMK 13-00275. Specifically, protection is granted for importations of the following pocket lighter model numbers bearing the above-listed marks: J-5, J-6, J-25 and J-26.

In accordance with *Lever Bros. Co. v. United States*, 981 F.2d 1330 (D.C. Cir. 1993), CBP has determined that the above-referenced gray market pocket lighters differ physically and materially from the pocket lighters intended for sale in the United States with respect to product construction and warning labels.

**ENFORCEMENT**

Importation of the above-referenced subject gray market pocket lighters is restricted, unless the labeling requirements of 19 CFR § 133.23(b) have been satisfied.
